The person selected for this position will be trained to operate the water treatment plant and the raw and treated water pipelines, and is <u>required</u> to obtain certain levels of certification within a specified timeframe (see below).

This position is responsible for performing specialized duties in the operation and maintenance of a 16.5 MGD conventional surface water treatment plant and 70 plus miles of supply and transmission water pipelines. Mechanical, carpentry, computer networking, and/or instrumentation experience is a plus. This job <u>requires</u> overtime, callback, and weekend work as needed.

Primary Duties/Responsibilities:

- Operate and maintain the water treatment plant and the raw and treated water pipelines
- Maintain, inspect, troubleshoot, report, and perform maintenance and repairs of plant and pipeline equipment
- Perform safe unloading, handling, mixing, and storage of chemicals
- Operate grounds keeping equipment to maintain plant and pipeline facilities and grounds
- Perform routine operational, maintenance and custodial duties
- Ensure cleanliness of assigned areas and proper storage of equipment and supplies
- Moderate to heavy physical effort required in connection with the operation and maintenance of the water plant and pipelines
- Overtime, on-call, and weekend work as scheduled
- Other duties as assigned

Required Certification/Licenses/Training/Other

- High School Diploma or GED
- Must possess a valid driver's license and a safe driving record
- State of Wyoming Level 1 Water Treatment license or the ability to obtain within 6 months of employment
- State of Wyoming Level 2 Water Treatment license **or** the ability to obtain within 1 year of employment
- State of Wyoming Level 3 Water Treatment license **or** the ability to obtain within 2 years of employment
- State of Wyoming Level 4 Water Treatment license or the ability to obtain within 3 years of employment
- State of Wyoming Level 2 Water Distribution license or the ability to obtain within 2 years of employment
- Operator must maintain State of Wyoming Level 4 Water Treatment license and State of Wyoming Level 2 Water Distribution license once they are obtained
- Within one year of employment, operators are required to have primary residence within 30 minutes of the Water Treatment Plant

Knowledge/Skills/Abilities:

- Must be able to access all areas of the water treatment plant (multi-level) and the raw and treated water pipelines
- Ability to perform basic mathematical calculations



- Ability to read, write and comprehend English (operational, process, safety and quality instructions)
- Proficient in the use of personal computers including word processing and spreadsheet applications
- Experience with SCADA systems and GIS map use is a plus
- Ability to establish and maintain effective working relationships with supervisors, other employees, and the public
- Ability to communicate effectively both orally and in writing
- Ability to comprehend and follow verbal and written instructions on a daily basis
- Ability to work without close supervision
- Ability to follow established safety protocols and programs
- Ability to learn the use of SCADA, controls, and HMI applications
- Ability to learn and show competence in the operations and maintenance of the Water Treatment Plant and the raw and treated water pipelines
- Ability to learn to maintain, inspect, troubleshoot, report, and perform maintenance and repairs of plant and pipeline equipment
